Personal data is only collected on this website with the knowledge and information of users.

2. WHAT PERSONAL DATA DO WE PROCESS AND WHERE DOES IT COME FROM?

Due to your relationship with us, we may process different categories of personal data, always depending on the service or product contracted with us. These data may be collected by any of the means that Neptuno Costadeje SL offers, both online and in person. The categories of data processed may be the following:

- Contact data
- Identification character of natural persons: name and surnames, DNI/identification document, telephone, email, address, signature.
- Special category data.
- Bank data.

If you have booked your stay through a travel agency or online travel agency, it will communicate your data to Neptuno Costadeje SL for the management of your reservation and/or contracting. Travel agencies or online travel agencies may use your personal data for their own purposes, so we will be dealing with another Data Controller. You can obtain information about the processing of your data by these entities by going to the Privacy Policy section of the agency's website.

In any case, if a third part y has provided us with your data, we will treat it within the purposes set out in this Privacy Policy.

3. PURPOSE. WHAT IS YOUR PERSONAL DATA USED FOR?

Neptuno Costadeje SL informs you that it may process personal data for the purposes indicated below, to the extent that there is a legal basis for each treatment as explained below.

The main purposes for which your personal data will be used are the following:

In the same way, Neptuno Costadeje SL may send information about activities related to tourism and leisure, such as cultural activities, excursions, sporting events, etc. that may or may not be offered in conjunction with our accommodation services.

In addition, by providing your data by any of the means provided, you guarantee the veracity of the data provided and undertake to communicate any changes that occur in them.

Remember that, when we ask you to fill in your personal data to give you access to some functionality or service, we will mark some fields as mandatory, since they are data that we need to be able to provide you with the service in question. Please note that if you decide not to provide us with such data, you may not be able to enjoy those services or features or send us your request.

4. LEGITIMATION. WHY DO WE USE YOUR PERSONAL DATA?

Neptuno Costadeje SL is entitled to use your personal data for different reasons, in particular the following:

Questions, requests or suggestions	If you send us a-query, request or suggestion without being registered with Neptuno Costadeje SL, we will use the data provided to respond to the query based on your consent and r legitimate interest.
	When a registered user makes us a query, request or suggestion, we use their data to respond based on the execution of the contract.
	In case of submitting a request to exercise the rights explained in point 7. RIGHTS YOU MAY EXERCISE, we will use your data based on a legal obligation.
Resume Submission	Your consent is understood in sending our resume voluntarily through electronic means or with the signature of the document for the p rocessing of your personal data.

5. CONSERVATION OF YOUR DATA. HOW LONG WILL WE KEEP THEM?

The personal data provided will be processed and kept for the time necessary to fulfill the purpose for which they are collected. Once this period has ended, we will keep your data duly stored and protected so that it can be made available to the competent Public Administrations, Judges and Courts or the Public Prosecutors Office during the limitation period for actions that may arise from the relationship maintained with the user and/or or during the legally established storage periods. Once the possible actions of each case have expired, Neptuno Costadeje SL will proceed to delete the personal data.

In the event that the legitimacy for the processing of your data is based on your consent, Neptuno Costadeje SL will keep your information as long as the user does not withdraw the consent first given.

6. TO WHOM DO WE COMMUNICATE YOUR DATA?

To fulfill the purposes indicated in this Privacy Policy, it is necessary that we give access to your personal data to entities that provide us with support in the services we offer, namely:

- Financial entities, business advice, transport, etc: companies necessary for the management of your reservation and stay.
- Collection management entities and insurers in order to carry out the claims against tour operators or clients as a result of the legitimate interest of Neptuno Costadeje SL in managing the collection of the services provided, as well as insuring the amounts pending payment.
- Third-party services, such as cloud-based services, payment processing technology services, services to carry out marketing
 initiatives, or services to conduct customer surveys on our behalf.
- Search engines.

• Apart from those indicated, Neptuno Costadeje SL will not transfer personal data to third parties, except by legal obligation. However, in the case of being transferred to a third party, the user will be previously informed requesting express consent for such transfer. The entity responsible for the database, as well as those who intervene in any phase of the treatment and/or the entities to whom it has been communicated -in any case, always with the corresponding authorization granted by the user-, are obliged to observe the professional secrecy and the adoption of the levels of protection and the necessary technical and organizational measures within its reach to guarantee the security of personal data, avoiding, as far as possible, unauthorized access, illicit modifications, theft and/or loss of data, in order to ensure the corresponding level of security of the files, according to the nature and sensitivity of the data provided by the users of this website.

7. RIGHTS YOU MAY EXERCISE

You can exercise any of the rights that we explain below, simply indicating the reason for your request and the right you want to exercise. In the event that we consider it necessary to be able to identify you, we may request a copy of a document proving your identity.

In general, you will always have the right to:

- Request access to your personal data, to know what data we have about you.
- Request rectification of your data: keep in mind that, by actively providing us with your personal data by any means, you guarantee
 that they are true and accurate and you agree to notify us of any changes or modifications to them.
- Request that we delete your data to the extent that they are no longer necessary for the purpose for which we need to treat them as we have informed you above, or that we no longer have the legitimacy to do so.
- Request that we limit the processing of your data, which means that in certain cases you can ask us to temporarily suspend the processing of the data or to keep it beyond the time necessary when you may need it.
- Request the portability of your personal data. This means that you will have the right to receive the personal data that you have
 provided to us in a structured, commonly used and machine-readable format, in order to be able to transmit it to another entity
 directly, whenever technically possible.
- Request the right to oppose the processing of your data when the processing of your data is based on our legitimate interest.
- Request not to be the subject of a decision based solely on automated processing, including profiling, that produces legal effects on him or significantly affects him in a similar way.

You can request the exercise of right through the following means:

Neptuno Costadeje SL must answer the request within one month of receipt of the request.

This period may be extended for another two months if necessary, taking into account the complexity and number of requests.

You have the right to withdraw the consent given at any time by sending an email to subdirector@neptunocostadeje.com. The withdrawal of consent will not affect the legality of the treatment carried out before the withdrawal of consent.

If you consider that your right to the protection of your personal data has been violated, you may file a claim with the Spanish Data Protection Agency, www.aepd.es.

8. WHAT HAPPENS IF YOU PROVIDE US WITH THIRD PARTY DATA OR IF A THIRD PARTY HAS PROVIDED US WITH DATA HIS?

There are occasions when you can provide data from third parties, for example, contact persons. If you provide us with Personal Data of third parties, you guarantee that you have informed them about the purposes and how we need to process your personal data.
